(a) I (We) will not export or re-export any products, technology or software manufactured or purchased from RECA Corp., to any embargoed or terrorist supporting countries (Cuba, Iran, Syria, Sudan, North Korea, etc.) unless otherwise authorized by the U.S. Government.

(b) I (We) will not sell, transfer, export or re-export any products manufactured by or purchased from RECA Corp. for use in activities, which involve the development production, use or stock-piling of nuclear, chemical, biological weapons or rocket and/or missile systems, or missile technology or use of our products in any facilities which are engaged in activities relating to such activities, weapons or products. I (We) will not sell, transfer, export or re-export any products manufactured by or purchased from RECA Corp. for use in any nuclear end-use activity such as nuclear explosive activity; research on or development, design, manufacture, construction, operation, or maintenance of any nuclear reactor, critical facility, facility for the fabrication of nuclear fuel, facility for the conversion of nuclear material from one chemical form to another or separate storage installation.

(c) I (We) confirm this product will not be used in or re-exported for any military end-use in China, Iraq, Russia or Venezuela.

(d) I (We) acknowledge that U.S. Law prohibits the sale, transfer, export or re-export or other participation in any export transaction involving RECA Corp.'s products with individuals or companies listed in the U.S. Department of Commerce's (Bureau of Industry and Security) Denied Persons List (DPL), Entity List, or Unverified List, as well as the U.S. Treasury Department's (Office of Foreign Assets Control) Specially Designated Nationals and Sectoral Sanctions Identifications (SSI) Lists or the Department of State's (Directorate of Defense Trade Controls) Debarred Party List; I (We) shall not export, re-export or transfer any RECA Corp. product to any said person or entity.

(e) I (We) certify that the above-mentioned goods will not be used, in their entirety or in part, for projects pertaining deep water oil exploration and production, Arctic oil exploration and production, or shale oil projects located in Russia; that the above-mentioned goods will not be transferred to the Crimea region of Ukraine; that the above-mentioned goods will not be used in oil and gas exploration, development or production projects located anywhere in the world in which a US sanctioned Russian firm or a US sanctioned Russian individual has a controlling or a 33% ownership interest; and that the goods will not be sold to the Venezuela Government or an entity in which the Venezuela Government has a 50% or more interest.

(f) I (We) will abide by all applicable U.S. Export Control Laws and Regulations for all products purchased from RECA Corp. and will obtain Export Licenses (e.g., Re-export Licenses) or other approval required by the U.S. Government, prior to export or re-export of RECA Corp.'s products.

(g) I(we) certify that I/we will put on notice our customers/end-users of this product that US export control law and regulations apply to the above-mentioned goods and that it may not be transferred/sold/exported or dealt with it in any manner prohibited by US export control law and regulations.

All products purchased from RECA Corp. and its subsidiaries **must** be exported or re-exported in compliance with United States Export Control Law and Regulations. No re-export or transfer to an embargoed country/person/entity or sanctioned industry is permitted without authorization from the US Government.
